**Money earning activities should not be needed unless a troop is planning for a large trip. Limited to two approved money earning activities per year.**

**Submit a telephone or email report to Council on the activity, including an evaluation and amount earned within 2 weeks of activity. If a report is not submitted, no other activities will be approved.**

**Guidelines:**

- 1) Submit request to Southern Region Office 30 days before money earning activity (*recycling projects do not require approval*). The troop leader will be notified of the approval/disapproval.
- 2) Troops must participate in cookie sales. No troop money earning activity may be held during the cookie sale.
- 3) **The money earning activity must be for specific upcoming Girl Scout troop activities.**
- 4) The money earning activity must be appropriate for the program level.
- 5) Must include a budget and anticipated profit for the activity.
- 6) Must use a separate form for each activity per date.
- 7) As a guideline, use Safety-Wise reference Standard 29.
